Role & Responsibilities of the ABC

- Coordinate and strengthen the school district's HIB policies to prevent, identify and address HIB of students.
- Collaborate with the ABS, the BOE and the CSA to prevent, identify and respond to HIB acts in the district.
- Provide data, in collaboration with the CSA, to the NJDOE regarding HIB of students.
- Meet with ABS at least 2 times each year to discuss and strengthen procedures and policies to prevent, identify and address HIB in the district.
- Execute other duties related to HIB as requested by the CSA.



The Process...The Results

- The School Climate Team (SCT) is required to evaluate its ABR implementation twice a year, from July 1 through June 30
- Eight core elements are evaluated and address all of the ABR requirements for schools
- The maximum grade a school may receive is 78
- A minimum score of 54 is needed in order to meet all necessary requirements

The Plan: Exceed Standards Our Progress

Targeted Areas for Improvement: Initiative 22-23

- Compliance with Timeline: HIB Timeline Cover Sheet was created for All Reports and Genesis HIB fields are required to be completed
- **Posting of HIB-related items on website:** Schools/District postings are current and feature more information/guidance than required
- Meetings with ABC: Monthly, if not more, in addition to 3 PD days
- School Climate Programs Implemented: ABSs submit a "Monthly Report" which is completed in collaboration with Princ. Reports are reviewed by the ABC and "highlights" are shared during monthly Culture & Climate Committee meetings
- School Climate Meetings: Schools were asked to schedule four (4), which exceeds requirement of two (2)
- **Professional Development:** ABC attended the NJDOE training for Updates and referred 2 new ABSs as well. ABC provides resources for HIB/School climate trainings/PD, conducts in-district department meetings including PD days, and on-going training and support for ABSs when needed
