- 1. Policy 2330 Proposed changes.
 - a. Changes to Paragraph 9: Weekend and holiday homework is discouraged. Make-up work, long-term projects and research papers may be assigned over periods that include weekends and/or holidays. However, if any homework, make-up work or long-term projects are assigned over any extended break from school including, but not limited to, Thanksgiving break, winter break, spring break or summer break, same may not be due until the second meeting of any class and/or within three days following such break, whichever is lesser.

- b. Changes to Paragraph 10: Teachers are expected to be aware of religious observances that may affect a student's ability to complete homework assignments.
 Reasonable extensions no less than one day/24 hours shall be granted upon request without consequences.
- c. We will discuss with Dr. Harrison Crawford via email and hope to have for first read soon.
