## G. MINUTES

Ronald Riddick moved to approve the minutes of the Public Board meeting held Monday, September 21, 2009; seconded by Carmen Taylor and approved by a vote of 6-0.

# H. SUPERINTENDENT'S REPORT

Dr. Alvarez thanked the staff, senior staff and PTA for all their support and encouragement during this past week with regard to the unfortunate issue at Watchung School.

Dr. Alvarez wanted to share the following good news with the public:

Montclair is one of a few school districts that will be participating in a pilot Fire Prevention Program with Dr. Frank Fields. He noted that this program will consist of students and parents watching broadcasts and giving students an opportunity to respond to questions during the school day.

Greg Woodruff, Montclair High School teacher, has been nominated Teacher of the Year by the New Jersey Council for the Humanities and will receive his award on October 24, 2009 at the Montclair Art Museum.

Dr. Alvarez noted that out of 400 students attending Yale Law School, the most competitive law school in the country, five of them are from Montclair High School.

#### 1. MHS – Student Coalition

Dr. Alvarez introduced Krista Voorhis, the Teacher Advisor for the Montclair High School Student Coalition. Ms. Voorhis announced the officers for the 2009-2010 school year as follows:

Petal Robinson – Co Advisor David Ellman – President Jamie Fanous - Treasurer Isabelle Foley – Secretary Melanie Hotz - Vice President

David Ellman and Jamie Fanous, who were in attendance, highlighted some of the events that are and will be taking place during the school year; i.e. pep rallies, fall sports, senior college application submissions, car washes, diplomatic core video conference and new clubs. They also noted that they are looking forward to a great year with their new Principal, who they stated is very enthusiastic and open to positive suggestions for the school.

Dr. Alvarez stated that the Board looks forward to their monthly reports.

# 2. Academic Achievement Report

Mrs. Terry Trigg-Scales presented the Academic Achievement Report for 2008. Mrs. Trigg-Scales spoke on the following district goals

- Improving academic achievement for all students
- Continuing to achieve equity and improve efficiency
- Promoting community engagement

Mrs. Trigg-Scales noted that student performance is looked at in four different ways

- 1. Demographic
- 2. Student learning Data
- 3. School process Data
- 4. Perception Data

Mrs. Scales stated that:

- It is an ongoing effort of staff to improve student performance.
- All staff members are familiar with APIE (Assess, Plan, Implement and Evaluate).
- Information being presented was prepared using preliminary enrollment data and that a comparison was done from 2002 through the current year.
- District goals were driven by Core Standards, No Child Left Behind and State Policy.
- Areas of concentration will be Language Arts Literacy and Math and students with special needs.

- District is influenced by visits from Tri State consortium, Governor's Awards, MSAN, CAPA/QSAC, visits from Quality New Jersey, Minority Student Achievement, District Leadership
- New Jersey has revised standards for proficiency for grades 3 and 4 students must now attain 50% possible points to attain proficiency
- Students did well with regard to the New Jersey Goal percentages in grades 3 through 11.
- The slides show the increases and decreases in each grade level (grades 5 to 11) according to group and ethnicity.
- The slides for Grades 8 include Science as well as Language Arts and Math.
- The HSPA tests results are a requirement for grade 11 students (a graduation test) since this is how the AYP is calculated.
- Students continuing onto colleges from Montclair High School have increased in number since 1999.
- Dr. Scagliotti and his staff are working very closely to target on instruction for special needs students and going to take very dramatic steps in these fields; i.e. new programs, professional development for teachers.
- It is a proven fact that many students who do not have access to special tutoring, cultural trips, computers, etc. are economically disadvantaged; therefore all students are not performing on the same levels but that Montclair is providing additional resources through Imani, Stars and summer programs.

Dr. Frank Alvarez added that it is also a proven fact that all students to do not have the same opportunities, resources and exposure and this too makes some students economically disadvantaged.

#### Board of Education Reports:

Mrs. Leslie Lombard reported on the following:

**Academic Sub Committee Meeting** – A presentation and update on the Learnia Program was given. Information on new programs funded by ARRA and professional development were addressed. A review of the Lucy Caulkins Program and its affect on the Writers Room was discussed.

High School Advocates for a Positive School Climate - Discussion were had on the issues affecting the school climate; i.e. students dress code, attitude and dress of faculty, gang awareness, alternative education options. In attendance were members of guidance, interschool police security, and staff members and the group plans on meeting twice a month to reach some action plans.

**Coffee with Dr. Alvarez at Edgemont School** – A discussion was held regarding the Lucy Caulkins program. Dr. Anderson is an early adopter of the program and is excited to expand this program. A discussion was also held on what is happening to address global education and reduce the achievement gap.

**District Leadership Team** – District goals were discussed as well as the Discretionary Funds Principals receive for their schools and how they use it for magnet programs. A discussion was had regarding the monies that PTA's raise for their schools and how this affects other schools.

North Star Charter School – Visit to the school was quite interesting especially the collaborative ways teachers work toward education (curriculum and lesson plans). The school puts a great deal of emphasis on parent communication – the parents must pick up their child's report card four times a year and meet with their child's teacher at that time. There is daily feed back between teachers regarding their lesson plans and goals.

Mrs. Shelly Lombard reported that she had attended Back to School Night at Montclair High School and agreed with what the students have been saying that Mr. Earle is wonderful and can always be seen around the school. Mrs. Lombard commented positively on that night's presentation by Mr. Earle.

Mrs. Carmen Taylor stated that she too had attended Back to School Night at Montclair High School and was moved by the energy felt in the school and by Mr. Earle's presentation.

Mr. Ronald Riddick noted that he nothing special to report but agreed with Mrs. Lombard and Mrs. Taylor about the energy level in the high school.

Ms. Shirley Grill stated that she attended the meetings with Mrs. Lombard. Ms. Grill wanted to note that government money we are receiving to do professional training for teachers for special need students actually does benefit all students.

Mrs. Grill advised that she had attended several Township meetings with the Mayor at which he discussed his concept of how to appoint Board of Education members. Mrs. Grill encouraged the community to also attend these meetings. Mrs. Grill stated that she was passing on questions/concerns received from the community to Central Office.

Mr. John Carlton advised that he attended an Imani Fund Raiser and that, as usual it was a terrific event. Mr. Carlton stated that since the State is re-examining the funding formula, a committee to review the school funding formula is being assembled and anyone that is interested in serving on this committee should contact the Board.

Resolution Re: Revision of Maximum Conference & Travel Amount

a. Resolution Re: Award of Contract for Curriculum Mapper Proprietary Software 2009-2010 Fiscal Year

WHEREAS, the Montclair Board of Education is in need of software that will be used to align and revise curriculum to the NJCCCS,

NOW, THEREFORE, BE IT RESOLVED that the Montclair Board of Education, after careful study and due deliberation does hereby award a contract to Collaborative Learning, Inc., for the purchase of Curriculum Mapper at a cost of \$72,750 in the year 2009-2010 and \$10,050 each subsequent year for maintenance and site-licensing.

6. Resolution re: Authorizing Settlement of Lawsuit and Claims in the Matters of Backstage Lighting v. Montclair Board of Education, Docket No. ESX-L-5499-09, and Claims for Fees Owed by Pakis Construction, Inc. Related to the Mt. Hebron Stage Project

Shirley Grill moved to approve the following Settlement Agreement:

WHEREAS, the Montclair Board of Education entered into an agreement with Pakis Construction, Inc. to provide construction services related to the Stage Renovations at Mt. Hebron School (hereinafter referred to as the "Project"); and

WHEREAS, Pakis Construction, Inc. hired Backstage Lighting & Rigging to subcontract some of the work on the Project; and

WHEREAS, a dispute arose among the Board, Pakis and Backstage regarding fees owed and delays that occurred in the Project; and

WHEREAS, Backstage filed a suit entitled <u>Backstage Lighting & Rigging v. Pakis Construction, Inc. and Montclair Board of Education, et al</u>, venued in the Superior Court of New Jersey, Essex County and bearing Docket Number ESX-L-5499-09; and

WHEREAS, Pakis Construction, Inc. filed a claim against the Montclair Board of Education for fees owed on the Project, which claim would proceed to arbitration if not settled; and

WHEREAS, Backstage, Pakis and the Board are desirous of settling this dispute amicably without further resort to litigation or arbitration; and

WHEREAS, the Montclair Board of Education finds that it is in the best interest of the school district to amicably resolve this dispute with Backstage and with Pakis without resort to further litigation; and

WHEREAS, the Board's legal counsel will prepare a Settlement Agreement that will resolve all claims for fees between and among Backstage, Pakis and the Board;

NOW, THEREFORE, BE IT RESOLVED that the Montclair Board of Education hereby authorizes the Board Attorney to enter into a settlement agreement that reduces the fees owed to Pakis Construction, Inc. by Seven Thousand Dollars (\$7,000.00) representing costs for delays to the Project, and that disposes of all other claims for fees from Backstage Lighting & Rigging and from Pakis Construction, Inc.; and

### L. COMMENTS

#### 1. Members of the Public

Dorothy Oliver applauded the Board for the transparency and professionalism in negotiating the Superintendent's Contract and allowing the community to be aware of all intimate details.

Deborah Wilson stated that on Friday, Members of the Board of Education received a copy of a memorandum to the Curriculum Sub-Committee on behalf of Glenfield parents. Mrs. Wilson requested that the following letter be read into the minutes:

In following the parent complaint question procedure we received, we recently have spoken to and/or corresponded with Dr. Anemone ,Guy Whitlock, Terry Scales and Dr. Alvarez about a situation at Glenfield Middle School involving the math curriculum. We are writing to bring what we consider a serious issue to your attention. Our children are currently taking 7th grade Algebra B and 8th grade Geometry and based on our experience parents are being given inconsistent and potentially misleading information about the middle school math curriculum as it relates to Algebra and Geometry in particular. In addition, we believe the following may be occurring as it relates to Algebra and Geometry. The district may not be providing appropriate curriculum direction and guidelines, Principals may not be following curriculum direction and guidelines and as a result teachers may be left to individually interpret the curriculum.

Answers to the following questions will provide critical information in general as we advocate for our children. In addition, we expect these answers may help us clear up our confusion and dissatisfaction with regard to recent decisions at Glenfield

involving the math curriculum. The questions are grouped into the following categories:

Algebra Readiness Test – we would like to understand what the district criteria is for taking the Algebra Readiness Test and who is responsible for making parents aware of this criteria. In the area of middle school Algebra and Geometry courses we like to know if middle school Algebra and Geometry are considered high honors courses. We looked at page 65 from the 2008-2009 Montclair High School Planning and noted that 8th grade Algebra B is listed as high honors and Geometry is listed as high honors. Who is responsible for communicating the middle school math curriculum to parents and is the information on the Glenfield website approved by the district? Is there a specific syllabus that teachers are required to follow and how does the district determine the failure rates for middle school Algebra and Geometry? In the area of 6th grade Algebra we would like to understand and get answers to what the district guidelines are for 6th grade Algebra with regard to testing, course work and grading standard. Who is responsible for making parents aware of these standards? We looked at a memo that was sent on May 13, 2009, regarding State Assessment and it was a communication to Chief School Administrators. On page 7 we found reference to Algebra for grades 7 through 12 but no reference to grade 6. How does the district determine student failure rates for grade 6 Algebra? In the area of middle school math and the SAIL program, we would like to know if our middle school Algebra and Geometry courses are part of the SAIL program and if so, where is this documented for parent access. Who is responsible for notifying parents of students' status in this SAIL program? We looked on the district's website, the SAIL overview does not indicate who will notify students and parents. What is the class size average for SAIL courses? Do the district's guidelines differentiate instruction in any particular teaching methods as inappropriate for SAIL courses? What is the homework standard for SAIL courses and is the standard the same as general education courses and finally in the area of middle school math homework assignments we like to understand and get answers to what is the district's policy for homework and how does the district determine how long in terms of the number of hours required for students to complete homework. We thank you in advance for your attention to this matter. We are available to meet with you to provide additional parent insight and/or answers to questions we believe is critical to provide transparency, facts and information to parents about the middle school math curriculum and we await your answers. The parents that participated in drafting this letter are Alexis and Michael Ellison, Marvin Deupree, Felipa Gurling, Dawn and Jason Harris, Masiel Rodriguez Vars, and Deborah and Curtis Wilson.

Mrs. Shirley Grill questioned what grade these parents represented and Mrs. Wilson responded that they were seventh and eighth grade parents. Mrs. Grill asked if there was a specific change that is causing parents to question the curriculum and Mrs. Wilson responded no. Mrs. Wilson noted that some staff changes were made and parents want to know the reasons why these changes were made. Mrs. Grill responded that the Board will review this matter

Dr. Alvarez noted that he has contacted the Department of Instruction and will get some answers. Dr. Alvarez also stated that the same curriculum should be taught regardless of who the teacher is and will get a response to parents by the end of the week.

Jason Harris, 155 Highland Avenue, stated that he was in agreement with the information in the letter and felt that misinformation was also given with regard to the number of hours being spent on homework and the failure rate. Mr. Harris asked that the following response from the State of New Jersey with regard to his press release be made part of the minutes:

Dear Mr. Harris

Thank you very much for sharing with us the success of the Agile Mind pilot program at Glenfield Middle School and the Montclair school district. It pleases me to learn of the success of this exciting mathematic program. As a former math teacher I found the information particularly exciting. It is a real pleasure to learn that Algebra and Geometry are alive and well in Montclair and has been embraced by the superintendent, principals and teachers. I enjoyed learning about one of New Jersey educational success stories. Once again, thank you and I wish you and all the students at Glenfield Middle School a very successful school year.

Mr. Harris was questioned if the parents had evidence that their children will not do well in the course. Mr. Harris noted that this teacher has never taught Geometry and feels that a teacher should have more experience before teaching a high honors course. Mr. Harris also stated that some children have dropped out of the class.

Masiel Rodriquez Vars, Co-president of PTA Council, stated that she was with the Glenfield parents and Mrs. Vars reiterated her concerns about the instructor having difficulty teaching the course. Mrs. Vars stated her concern that students in this class may have a tough year when they enter the high school.

#### 2. Board Members

Mrs. Carmen Taylor stated that she had attended a Fourth Ward Council Meeting held by Dr. Renee Baskerville. Mrs. Taylor noted that this meeting was very well attended and honored four fourth ward members, one being Guy Whitlock. Mrs. Taylor expressed her gratitude to Dr. Baskerville for a very well organized meeting.

Mr. Ronald Riddick commended the district for participating in the Minority Student Achievement Network which was held in Chicago. Mr. Riddick noted that his son was a participant and brought home much excitement and enthusiasm with regard to the creation of programs on inclusion within schools to bring all students together regardless of race or ethnicity.

Ms. Shirley Grill wanted to clarify the issue of fund raising. Ms. Grill noted that she felt that PTA's in different schools are not raising the same amounts of money and felt that possibly all monies raised should be funneled through MFEE so that there would not be an inequity in school fundraising.

Ms. Leslie Larson commented that she would like the Board to have in depth presentations on various programs. Ms. Larson stated that she felt this would be a way that the Board could be assured that all students are receiving the same curriculum and it is taught the same way in all schools.

Mrs. Shelly Lombard thanked Terry Trigg-Scales and Dr. Frank Alvarez in advance for the work they will be doing with regard to the math curriculum. Mrs. Lombard noted that it is critical how decisions are made with regard to curriculum.

Mrs. Lombard wanted to add a comment to Mr. Carlton's presentation regarding the funding formula. Mrs. Lombard wanted everyone to be aware that the average district receives 40% of their budget from State funding and Montclair receives 9-10% in funding; therefore it is critical that we lobby for additional funding.

Ms. Lombard wanted to thank Mrs. Leslie Larson for setting an excellent example of a new board member by her attending meetings and coffee discussions.

At 9:50 p.m. the Board and Dr. Frank Alvarez went back into executive session to discuss personnel issues.

At 11:04, Shelley Lombard moved that the Board return from executive session; seconded by Shirley Grill and approved by a vote of 6-0.
